INSTRUCTIONS TO BIDDERS

1. The new school bus must meet current F.M.V.S.S. Title 49 Standards. The school bus must conform to present School Bus Construction Standards, State Of Ohio Highway Patrol 4501-5 School Bus Minimum Standards: 4501-5-01 through 4501-5-09.
2. In addition must have: **COMPLY WITH ALL**
 - Minimum Gross Motor Vehicle Wt: 26001 Lbs.
 - Black "School Bus" Lettering/Fluorescent Striping
 - Seats (12) – 39/39 New York High Back DOT
 - Standard seat belts in four rear seats (seats: 9, 10,11,12)
 - Driver's Storage Compartment
 - ABS Air Brakes
 - Air operated split pane glass outward opening entrance door
 - Exhaust modification to exit out side (extra long exhaust pipe)
 - Vandal locks: Entrance door & Rear Emergency Door
 - AM – FM – CD/DVD
 - Strobe Lights
 - Automatic Transmission
 - 3 12 Volt Battery System
 - Mounted Fire Extinguisher
 - Noise Suppressant Switch
 - Crossing Gate Front Mounted (Air) – Yellow Blade, Bumper Mounted
 - Flasher System: 8 Warning Lights, 8-Lamp System, Electronic Relay Flasher, Sequential Operation, Red Lights Activate After Amber Lights With Door Open Including Light Exterior Check Automatically Activates Lights For Pre-Trip Inspection
